2B. IS PATIENT DATA SAFER NOW THAN IT WAS BEFORE HIPAA WAS ENACTED?

It has been 23 years since the Kennedy/Kassebaum bill, signed into law on August 21, 1996 and morphed into the Health Insurance Portability and Availability Act. While HIPAA was initially intended to increase the portability and availability of health insurance coverage for employees between jobs, it also addressed patient privacy (April 2003) and security measures (April 2005) to protect patient data. Additions to the law/regulations have included the Enforcement Rule (March 2006), Breach Notification Rule (September 2009), Compliance Audit Programs (2011/2012) and the Final Omnibus Bill (March 2013) which mandated specific encryption technologies to use.

One would think that with this amount of legislative direction and auditing oversight that patient records were never safer. However, the opposite is true. Many of the HIPAA changes have in fact made patient records more, not less, vulnerable to unauthorized exposure. This, coupled with advancements in technology, have made our health data more vulnerable than any other time in history. In this presentation, we will review what has driven this unintended consequence and what organizations need to do to better protect patient data.

With the transition of patient health care records from paper to electronic nearly complete, both patients and providers are one step closer to having meaningful access to and the ability to share patient health information when it could most positively impact patient treatment and care. However, limitations on the interoperability of EHRs and the frequency of data blocking have been significant impediments to access and data sharing. In February 2019, HHS proposed new rules issued by CMS and ONC to end data blocking and promote the sharing of patient information. This session will review the ONC's proposed rules, review the seven activities which are deemed NOT to be information blocking by the ONC, and provide some practical recommendations for providers to ensure that their practice policies and procedures do not unnecessarily block access to or the sharing of patient data.

REGULATING THE RHYTHM: CODING FOR CARDIAC ARRHYTHMIA PROCEDURES

Does your heart "flutter" at the thought of coding for electrophysiological (EP) studies? Do you feel yourself having an attack of "tachycardia" when you are trying to determine the correct codes related to AICDs? Or perhaps your heart goes into slo-mo (bradycardia) when you are attempting to code for pacemakers. No worries, OHIMA has you covered. Join your coding colleagues for two presentations that will help alleviate the "pitter-patter" and get you on the pathway to understanding arrhythmias, and correctly assigning ICD-10-CM/PCS and CPT codes related to these conditions.

The principal diagnosis is defined in the Uniform Hospital Discharge Data Set as "the condition established after study to be chiefly responsible for occasioning the admission of the patient to the hospital for care." In order to determine which diagnosis is the best representation of the focus of care, the entire record must be reviewed. In order to determine this, many things must be evaluated. What occasioned the admission and would it normally cause an inpatient admission? What do the coding guidelines state? What clinical indicators are present? Was the condition present on admission and managed, evaluated, assessed or treated during the stay? Is there consistent and clear documentation of the condition throughout the record? This presentation will delve into coding guidelines, coding clinics, denial topics and case examples surrounding principal diagnosis selection.

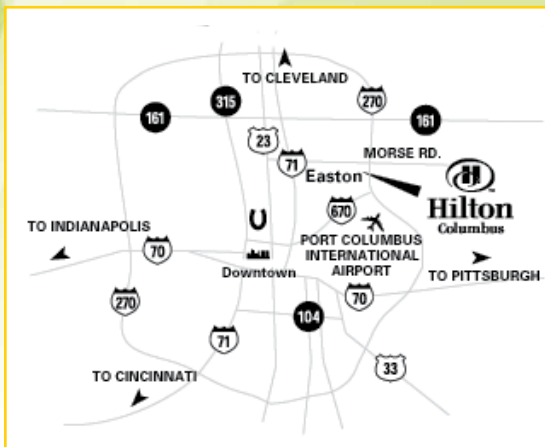
